Collection Abstract:

This collection consists of two Southern Pacific Lines employee time tables showing freight and passenger train schedules for railroad lines in Texas and Louisiana. They also show rating of engines in freight service, special instructions to employees, interlocking whistle codes, company surgeons, division officials, and a map of the divisions. One is time table number 4 for the Beaumont Division, dated April 4, 1926; and the other is time table number 1 for the Beaumont Division and Terminals Division, September 7, 1930.

Biographical/Historical Note:

The Southern Pacific Railroad Company was chartered in California on December 2, 1865. By 1900, the company had domain over several smaller railroads throughout the South, and those running in East Texas included the Texas and New Orleans Railroad Company, the Houston, East and West Texas Railway Company, and the Houston and Shreveport Railroad Company. In 1901, the Union Pacific Railroad Company acquired control of Southern Pacific, but was ordered by the United States Supreme Court to sell all SP stock. In 1996, the UP completed its acquisition of the SP.

Collection Scope and Content:

This collection consists of two Southern Pacific Lines employee time tables for railroad lines in Texas and Louisiana. These include lines of the Texas and New Orleans Railroad Company, the Houston, East and West Texas Railway Company, and the Houston and Shreveport Railroad Company. One is for the Beaumont Division, time table number 4, and is dated April 4, 1926. The other is for the Beaumont and Terminals Divisions, time table number 1, and is dated September 7, 1930. They are divided by subdivisions within the division and provide an arrival and departure schedule of passenger and freight trains within each district. They also show rating of engines in freight service, special instructions to employees, interlocking whistle codes, company surgeons, division officials, and a map of the divisions.
