Collection Abstract:

Lottie Wimp Temple was the personal secretary and wife of Arthur Temple, Jr., a successful East Texas businessman in the lumber industry and other interests. This collection consists of correspondence, annual reports, and political materials documenting Lottie Temple's work for the Diboll Insurance Agency, her involvement in Lyndon B. Johnson's 1964 presidential campaign, and her management of Arthur Temple's business interests and activities, and her interaction with members of the Diboll community.

Biographical/Historical Note:

Lottie Dean Wimp Temple was born on December 13, 1927 in Groveton, Texas, daughter of Oda and Ralph Dean. While living in Rockland, Texas, she graduated as valedictorian from Colmesneil High School and attended Pineywoods Business College. She married Robert Dean Wimp on November 27, 1946. They had one son, David Wimp, born on August 25, 1951. In 1944, at the age of 16, she began working for the Temple Lumber Company's retail yard in Lufkin, Texas as a bookkeeper. Arthur Temple, Jr. employed her as his personal secretary in 1948 after he became vice president of Southern Pine

Lumber Company in Diboll, Texas. When they married in 1963 she remained his personal secretary and managed their business affairs.

She helped found then manage the Temple Credit Union. She operated the Diboll radio station KSPL; served as president and secretary of the board of Exeter investments, Inc.; was a partner in Bartlett, Baggett and Shands Insurance Agency; secretary, treasurer and board director of T and T Corporation; board director of Green Acres Convalescent Centers, Inc.; and board director for First Bank & Trust in Diboll for 10 years.

Temple was active in the Diboll community and was very competitive in the Diboll Day fundraising activities. She was a founding director of the Katherine Sage Temple Day Care Center; founding member of the board of the Angelina County/Cities Health District; board member of the T.L.L. Temple Memorial Library; and board director and trustee for Memorial Health System of East Texas. The annual LaDiDa ladies invitation golf tournament at Crown Colony Country Club was founded in her honor in 1983.

Lottie Temple died on March 7, 2002.

Collection Scope and Content:

The Lottie Wimp Temple Papers has been arranged into three series. The first series consists of correspondence sent and received concerning the operations and individual policies of Diboll Insurance Agency, dated 1953-1955. These records document insurance for the Southern Pine Lumber Company employees and other Diboll and Angelina County residents. The second series consists of correspondence, notes, brochures, bumper stickers, and posters documenting Temple's involvement with Lyndon Baines Johnson's 1964 presidential campaign in East Texas. The third series consists of correspondence documenting Temple's many business, community, and political activities, as well as her administration of Arthur Temple's business affairs. This includes her work with Bartlett, Baggett, and Shands Insurance Agency, the Katherine Sage Temple Daycare, and Diboll Day. The folders containing records relating to Christmas parties and gifts reflect upon Temple's involvement in the Diboll community. Also included are materials on Lyndon Johnson's inauguration in 1964. The correspondence dates between the 1930s-1993 and is organized alphabetically. The annual reports series contains reports from various businesses that Arthur and Lottie Temple were involved with or had an interest in. They date 1976-1995 and are arranged alphabetically.

Arrangement: The collection is arranged in chronological order with original order being maintained when possible. It has been arranged into three series.
