SUBSCRIPTION GUARANTEE BOND

KNOW ALL MEN BY THESE PRESENTS, that we, CROWELL PUBLISHING COMPANY, as Principal, and NATIONAL SURETY CORPORATION, as Surety, are held and firmly bound unto all purchasers of subscriptions to periodicals, issued or sold by the Principal, in the penal sum of Ten Thousand and 00/100 (\$10,000.00) Dollars, for the payment of which, well and truly to be made, we bind ourselves, our successors and assigns, firmly by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH, That

WHEREAS, the Principal has authorized or may hereafter authorize various persons to sell and take subscriptions for said periodicals, and to receive payment in whole or in part for same, and to issue receipts for such payments;
