NOTICE: TEXAS LAWS, ACTS OF THE 38TH LEGISLATURE OF 1923, PROVIDE THAT UNLESS THE OWNER OR OWNERS OF SUCH LANDS OR LOTS DESCRIBED HEREIN SHALL PAY TO THE TAX COLLECTOR THE AMOUNT OF TAXES, INTEREST, PENALTY AND COSTS AS SET FORTH IN THIS NOTICE WITHIN 30 DAYS FROM DATE OF THIS NOTICE, THEN AND IN THAT EVENT, THE COUNTY OR DISTRICT ATTORNEY WILL INSTITUTE SUIT AS SOON THEREAFTER AS PRACTICABLE FOR THE COLLECTION OF SUCH MONEYS AND FOR THE FORECLOSURE OF THE CONSTITUTIONAL LIEN EXISTING AGAINST SUCH LANDS AND LOTS.

SECTION 4 PROVIDES: DUTIES PRESCRIBED ARE MANDATORY ON TAX COLLECTORS, COUNTY AND DISTRICT ATTORNEYS AND OTHER OFFICERS, STATE AND COUNTY, SUBJECT TO FINE OF NOT LESS THAN \$100.00 AND NOT MORE THAN \$1,000.00 AND SUBJECT TO REMOVAL FROM OFFICE.
