## INFORMATION TO TAXPAYERS

List your property for taxation between Jan. 1st and April 30th each year, and tax collector will send tax notice in Oct. In listing your property be careful to give correct abstract or lot and block number, name of sub-division or city and correct acreage. If property is a portion of a lot or block, state what portion.

If First Half of taxes is paid on or before Nov. 30, 1942 the remaining half may be paid at any time on or before June 30, 1943 without penalty. If one-half of taxes is not paid by Nov. 30, 1942 then all taxes are due not later than Jan. 31, 1943. Feb. 1% penalty and 6% interest per annum which is equivalent to 1½% penalty and interest per month. March -total 3% April-total 4½%, May-total 6%, June-total 7½%, July-8% penalty plus 6% interest from Feb. 1st.

Full payments may be made as follows: 5% discount on ad valorem tax payments 90 days before Jan. 31, 1943. 2% discount on ad valorem tax payments 60 days before Jan. 31, 1943. 1% discount on ad valorem tax payments 30 days before Jan. 31, 1943.

Discounts do not apply to poll taxes. All poll taxes must be paid with or before payment of ad valorem taxes.
