Title to said merchandise and any additions thereto or substitutions therefor is retained by you until all amounts payable hereunder are fully paid in cash. Said merchandise shall remain personal property and not become part of the freehold.

Time is of the essence hereof; if you deem the indebtedness insecure, or if I fail to pay any of said installments as above set forth, all remaining installments shall without notice become payable forthwith, and I agree to return said merchandise to you and you may without notice or demand and without legal process enter the premises and take possession of said merchandise and retain all prior payments as compensation for its use. Said merchandise may be sold with or without notice at private or at public sale at which you may purchase without having the merchandise present at the place of sale, and the proceeds thereof, less expenses, credited upon the amount unpaid, and in either event, as liquidated damages for the breach of this contract, I agree to pay any deficiency forthwith, plus 15% thereof for attorney's fees. Waiver of any default shall not operate as a waiver of other de-

faults. Your assignee's right shall be independent of and free from any claim by me against you, all of which I agree to settle directly with you. Should I make payments to you for transmittal to First National Bank, you shall be acting as my agent and not as the agent of the First National Bank. I agree to pay promptly when due all taxes upon said merchandise or upon this contract, and not to remove said merchandise from the address where installed without your prior written consent. Upon full payment by me, First National Bank may deliver any and all original papers to you for me.

No other extension of credit exists or is to be made in connection with my down payment on this merchandise. No agreement, arrangement or understanding, past or present, regarding my purchase or payments, and no guaranty, representation or warranty, whether oral or written, expressed or implied shall be binding on you or your assigns unless expressly contained herein in writing duly authorized. I acknowledge receipt of a true copy hereof.
