SEPTEMBER BOARD MEETING HELD IN LUFKIN - NEW DIRECTOR NAMED

The regular monthly meeting of the Deep East Texas Regional Mental Health Mental Retardation Services' Board of Trustees was held September 28th, in Lufkin. Dr. Jack G. Martin was appointed new Director of Mental Health Programs by the Board of Trustees. Dr. Martin received his Ph.D. from Walden University. He is currently employed by the Sabine Valley Regional MHMR Center as Director of Program Development. will assume his new position on November 1, 1976. Dr. Martin will replace Mrs. Betty Ecker, who is transferring to the newly created position of Director of Program Evaluation and Planning. Other agenda items included consideration of proposed revision in fee schedule, discussion of operations and construction grant request, discussion of state hospitals and state schools admissions statistics and consideration of personnel matters. Minnie Thomas of San Jacinto County was approved as a member of DETRMHMRS Regional Volunteer Services Committee, and James Donohoe, Coldspring, and Kenneth M. Wright, Sheppard, were approved as members of the San Jacinto County Advisory Council.


HEW GRANT FOR EAST TEXAS REGION ANNOUNCED

Congressman Charles Wilson's office announced this week the awarding of a U. S. Department of Health, Education and Welfare, (HEW) staffing grant in the amount of \$343,159 to DETRMHMRS. The grant will provide prescreening, aftercare and prevention services for mental health clients. The grant will also provide 22 positions for mental health workers for the 13 county region, and could run up to eight years, which would enable DETRMHMRS to greatly increase mental health caseloads and improve overall mental health services in our region.




Getting "Directions" Ready for Mailing

HOUSTON COUNTY SHELTERED WORKSHOP SOON TO OPEN

A Texas Rehabilitation Commission Grant in the amount of \$64,351 has been awarded DETRMHMRS for the establishment of a sheltered workshop in Houston County. The workshop will provide a full array of vocational, personal and social adjustment training for older mentally retarded clients. The program will solicit manufacturing, assembling, and other types of contracts from area businesses and industries while at the same time provide vocational training for the clients.



PLANS FOR DAY TREATMENT-ADMINISTRATION FACILITY PROGRESS

The Day Treatment/Administration Facility pictured on Page 1 will soon be a reality. A \$225,000 HEW Grant, together with a grant of \$45,000 donated by the T.L.L. Temple Foundation, and \$30,000 from the budget are the funding sources for this \$300,000 project.

The building, to be located on Loop 287 South, Lufkin, will contain approximately 8,300 feet of floor space and will house the Day Treatment Program and the Central Administration

Staff.

STAFF ATTENDS TYLER WORKSHOPS

Sunrise Manor residents and some Lufkin Workshop clients are currently attending the classes. Younger adults are taught by Judy Winger and Lynn Jones. Buford and Melissa Abeldt are the teachers for the older adult class.

NURSING HOME SEMINAR WELL ATTENDED

A seminar for nursing home administrators and directors was held on Friday, October 15 at the Holiday Inn, Lufkin. The meeting was well attended by nursing home, Department of Public Welfare and DETRMHMRS' personnel. The theme of the conference was promoting mental health in the aged. Bruce London, M.S.W., Center for Studies on the Aging, North Texas State University, served as seminar leader. Also participating in the seminar was Pat Wolters, R.N., DETRMHMRS' staff nurse. Mr. London discussed such topics as identifying and meeting mental health needs grief and depression and confusion and behavior problems. He also presented a film entitled "The Priory Method". Mrs. Wolters discussed overall DETRMHMRS' programs and specific programs for the aged now underway or soon to be implemented. The seminar was jointly sponsored by the Deep East Texas Chapter of the Texas Nursing Home Association and the Deep East Texas Regional Mental Health Mental Retardation Services.
